## Prosecutor in 9/11 Terrorist Trial To Speak at Flight 93 National Memorial on Saturday

**SHANKSVILLE, PA** – Former U.S. Deputy Attorney General Paul McNulty, who oversaw the prosecution of 9/11 terrorist conspirator Zacarias Moussaoui, will be the special guest at the final Flight 93 Speaker Series of the summer on Saturday, August 17 at 12 noon and 2 p.m.

Both Speaker Series sessions are open to the public free of charge at the Learning Center of Flight 93 National Memorial.

The program will highlight McNulty's involvement with the 2006 Moussaoui trial, which made public much of the evidence investigators collected about the September 11 terrorist attacks, including Flight 93. He will discuss the events of that day and the legacy left by the Heroes of Flight 93.

McNulty previously served as U.S. Attorney for the Eastern District of Virginia. He currently is president of Grove City College in Grove City, Pa.
